



VOLUNTEER AGREEMENT AND RELEASE FROM LIABILITY

- 1.) I _____ agree to volunteer for the Denver Public Schools Foundation Back to Class Bash to be held August 9, 2024 at one of the pre-determined DPS school sites from approximately 7:00 to 11:00 a.m. (times may vary). The event will be outdoors. I affirm I am at least eighteen years of age as of the date of the event or will obtain parent or legal guardian approval.
- 2.) As a volunteer, I understand I will not be compensated for any time spent volunteering, nor am I entitled to benefits, including employment insurance benefits upon the termination of this agreement or as a result of this service.
- 3.) I am aware my time spent volunteering may require periods of standing, sitting, or lifting and will require the exercise of reasonable care to avoid injury. I agree to accept any and all risks of personal injury and property damage.
- 4.) I UNDERSTAND IF I AM INJURED OR BECOME ILL IN THE COURSE OF THE EVENT, I AM NOT COVERED BY DENVER PUBLIC SCHOOLS FOUNDATION'S WORKERS' COMPENSATION PROGRAM. I authorize Denver Public Schools Foundation to administer or to seek emergency medical treatment on my behalf in case of injury, accident or illness to me arising from my involvement as a volunteer. I understand I will be responsible for medical costs incurred by such accident, illness or injury.
- 5.) I do hereby certify to the best of my knowledge and belief I am in good health. I agree to not participate if I am currently experiencing or have recently experienced symptoms of COVID-19 or any other illness such as fever, cough, shortness of breath, loss of smell or taste, among other symptoms. I hereby advise the above named has the following allergies, medicine reactions or unusual physical conditions, which should be made known to a treating physician:

I agree to dress myself (or underage participant) appropriately as to mitigate risk of physical injury to myself including, but not limited to: wearing clothing, shoes, and protection such as a hat, sunglasses, or sunscreen appropriate for physical activity involved in this event; and dressing in conjunction with the weather. - 8.) I am fully aware of the risks connected with volunteering in this event whether specifically listed in this Release or not, and I voluntarily elect to volunteer in this event knowing that this participation involves these risks.
- 9.) Assumption of Risk, Waiver of Liability, Release, and Covenant Not To Sue. In consideration for volunteering in this event, I voluntarily agree for myself, my family, heirs, assigns, executors, and administrators to the following:
 - a. TO ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me, or any loss or damage to property owned by me, as a result of volunteering in this event.
 - b. TO RELEASE, WAIVE, HOLD HARMLESS, DISCHARGE, AND COVENANT NOT TO SUE Denver Public Schools Foundation from any and all liability, claims, actions, demands, expenses, attorney fees, breach of contract actions, breach of statutory duty or other duty of care, warranty, strict liability actions, and causes of action whatsoever, that I might have or may acquire in the future, arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while volunteering in this event including, but not limited to, any claim that the act or omission complained of was in whole or in part by the negligence or carelessness, however caused, by any of its officers, directors, employees, agents, or contractors of Denver Public Schools Foundation.
- 10.) I agree to observe and obey all rules and safety procedures that accompany this event and to abide by any decision of an event official relative to my ability to safely volunteer in the event. I agree to exhibit appropriate behavior at all times and to obey all laws. Denver Public Schools Foundation and/or event officials may dismiss me should my behavior endanger the safety of or negatively affect an event, person, facility, or property of any kind.

I understand the materials and tools provided by Denver Public Schools Foundation are and remain the property of Denver Public Schools Foundation, and I agree to return these tools and any remaining materials to Denver Public Schools Foundation at the end of this event.
